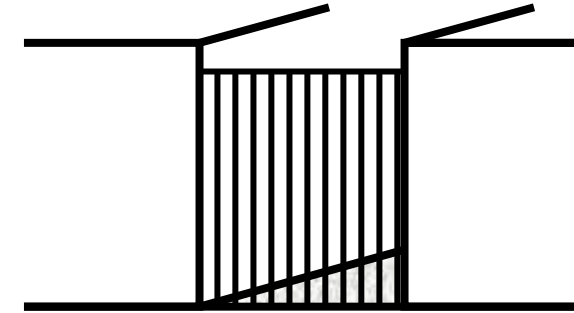

## What is Passageway Gating?

'Passageway gating' is the process of putting up a lockable gate to control access to a passage, sometimes referred to as alley gating.

## Why is it done?

So that only authorised people have access to the passageway, often for the purposes of crime reduction but also to allow improvements to the area.

## Where can I get further information?

Passageway gating needs careful consideration to ensure that it is done properly and to avoid problems later. **The Safer Stockport Partnership** has published a guide entitled:

### 'Private Passageway Gating — A Guide to Gating Private Passageways in Your Neighbourhood'

that introduces both the benefits and the issues regarding passageway gating. It also contains a step by step guide dedicated to helping you through the process of getting a private access passageway, which is not part of a through route, gated.

**The Guide is ONLY aimed at the gating of privately owned, private access, passageways that are not part of a footpath, through route, or Public Right of Way.**
